Removal of Assistantship NR Tuition Waivers	Tuesday July 14	All assistantship NR tuition waivers will be removed for students who failed the assistantship audit and eligibility documentation was not submitted.

Report names are pwt_029_XX_waiv_assist_notelig and pwt_029_XX_waiv_assist_review.
 - ❖ The audit process will begin Tuesday, July 7th. Review students who appear on the pwt_029_XX_waiv_assist_notelig report for Tuesday, July 7th. These students will have their assistantship NR tuition waiver removed Tuesday, July 14th if documentation of eligibility is not received by SBS.
 - ❖ **SBS will need to receive documentation of eligibility no later than 5:00 p.m. on Friday, July 10th.**
