These reports are available for you to review and make adjustments in TWAPMTS as necessary through the close of TWAPMTS on **Friday, February 16, 2024**. Report names are pwt_029_XX_waiv_assist_notelig and pwt_029_XX_waiv_assist_review.
- ❖ The audit process will begin on **Monday, February 19, 2024**. Review students who appear on the pwt_029_XX_waiv_assist_notelig report for **Monday, February 26, 2024**. *These students will have their assistantship NR tuition waiver removed on Wednesday, February 28, 2024*. If documentation of eligibility is not received by SBS.
- ❖ **SBS will need to receive documentation of eligibility no later than 5:00 p.m. on Monday, February 26th.**
